Both election evenings promise to be exciting, because key County, State, and Federal offices are in contention. These include: partisan County and State Assembly and Senate offices, five constitutional offices of the state (Governor, Lieutenant Governor, Sect. of State, Treasurer, and Atty. General) as well as all US House seats and the US Senate seat currently held by Russ Feingold. Election night will be interesting, so keep the date open.

## **NEW CITIZEN/NEW VOTER**

The revised edition of the Voter's Guide has been printed! Enormous thanks go to Joann Kreimandahl for the many hours she spent on the text and layout, and to Ruth Snedic and Dorothy Sherman for their input/review and coordinating with the printer. The new Guide is easy to read and printed in beautiful red, white, and blue colors. We are now awaiting response from funding sources.

Here are the data from the naturalization ceremonies at the Federal Courthouse:

- April 22nd - 44 of 145 new citizens registered to vote
- May 20th - 99 out of 219 new citizens registered to vote
- June 10th - 113 out of 299 new citizens registered to vote.

Volunteers for all these dates included Ruth Snedic, Joann Kreimendahl, Gloria Weiskotten, Virginia Sandquist, Beverly Katter, Diane Steigerwald, Barbara Overstreet, Helga Guequierre, Sr. Paula Marie Jarosz, Sharon Munson, and Dorothy Sherman.

We are now emailing our Special Registration Deputies about twice a month to appeal for volunteers at the court dates and any other voter registration opportunities. If you are a trained SRD but have not received one of the emails, or if you are not a SRD but would still like to assist in distributing our new Voter Guide, please let us know so we can make sure you are on the email list.

A few details about the ceremonies you may not be aware of:

- Most volunteers use metered street parking at \$1.50 per hour. If you get a receipt the League will reimburse you.
- We enter the front doors and must go through security inside.
- We sit in the jury box of the courtroom. The ceremonies last about 20 to 40 minutes.
- The voter registration takes place in the atrium on the first floor.
- You must bring your SRD number with you and a copy of your certification.

Pauline died in November at age of 104 years. LWV was her favorite organization. She was Vice President and active

in the study of international relations and the Great Decisions program. She was a graduate of UW Madison and taught history at Janesville High School until she married and was not allowed to work. Pauline was one of the founders of Laubach Literacy Association (now Wisconsin Literacy Association) and taught adults how to read 3 hours every week for 30 years. She exercised 3 hours 3 times a week till she was 98 years old, then reduced it to 2 hours 3 times a week. She loved folk dancing, bridge and crossword puzzles. She never took medicines. AMAZING!

### **Congratulations, Barbara Hussin!**

Barbara is the 2010 recipient of the state Leagues' Meg McLane Advocacy Award. In the late 1990's Barbara became the chair of the newly reconstituted Legislative Committee. Under her leadership the committee was broadened so its members came from outside the state board and Madison. Since at least 2004, Barb has been following the Corrections portfolio on the Legislative Committee and advocated for the rights of individuals who are incarcerated or trying to reintegrate into society following prison.

For many years in the early 90's Barb was the League lead of a joint Benedict Center/League of Women Voters Milwaukee County Court Monitoring Project (CMP) dedicated to finding alternative solutions to overcrowding of men and women in the Milwaukee County Jail. CMP activists elected to create a Revolving Bail Fund to loan 50% of the amount of very low bail (initially \$1500) to individuals unable to pay bail to be released before their court date, which was often weeks away. Barb researched the availability of funds and the Benedict Center secured a \$25,000 grant to seed the bail fund.

Equally as meaningful, but on the fun side, Barbara's golfing led her to found the Badger Mutual Insurance/Brown Deer Women's Amateur Golf Tournament in 2000. The focus of the tournament is a charity that provides funds to two centers, Lissy's Place, which supports disadvantaged young women who have aged out to the foster care system, and Belle Resource Center, which supports victims of domestic abuse. Both help clients become responsible, independent members of our community. In 2008 the tournament raised a total of \$18,000 for the charities.

I've taken the liberty of emphasizing the word "our" here, because I understand the essence of her address was that recent court decisions have put the courts in moneyed pockets (my words). Those decisions have seriously undermined the fairness, independence, impartiality, neutrality and non-partisanship of our courts that we all must be able to count on in court. League will address the issue in action and program this coming year.

In addition to electing State board members and adopting a budget & program for the next year, delegates heard about the Membership Recruitment Initiative that is now expanded to include Wisconsin. Our League is eligible to apply, so encourage your board to apply and grow our League! The Initiative works!
